S609(a)	Requires S of State to initiate negotiations for bilateral / multilateral treaties to protect sea turtles.
S609(b)(1)	Imposed a ban on shrimp harvested with commercial fishing technology which may adversely affect sea turtles.
S609(b)(2)	Provides that the import ban will not apply to nations that are certified.

## 2 ways to be Certified under s609 and as set out in the Guidelines

## In 1999 – s609 was not amended but 1999 Guidelines indicate:

That the prohibition in Section 609 does not apply to:

(a) ...

(b) shrimp harvested by trawlers using TEDs comparable in effectiveness to those required in the United States

(c) ...

(d) Shrimp harvested in ... circumstances that the Departmetn of State may determine ... does not pose a threat of the incidental taking of sea turtles.
